


THE TRIBAL IN THE MIRROR OF HISTORY

- ➤ Meaning: The term Adivasi is a Sanskrit word which means Adi-beginning and Vasi-dweller.
- ➤ **Definition**: "A Tribe consists of a group of families who are bound together by kinship, usually descending from the common mythical or legendary ancestors and who live in a common region, speak a common dialect and have a common history." Dr. B. H Mehta

- ➤ Tribal History Prior to Independence: This encompasses how tribal people are revolting and showing their resistance to the exploitation
- ➤ Imposition of Restrictions: It shows how people of power are imposing restrictions on their culture, tradition, land forest etc
- ➤ Tribal Revolution Post Independence: This includes how tribal people are revolting against the exploitation in the modern era.

NO MORE DANCING TO YOUR TUNE(cont...)

- Condition of the tribal people in the post-modern era continued marginalization and loss of land, struggles with identity amid rapid modernization, limited access to quality education and healthcare, cultural erosion due to mainstream influence.
- ➤ Infrastructural development and tribal Conflict Displacement, loss of livelihood, lack of consent and compensation
- ➤ Condition of tribal woman- poverty, illiteracy and limited healthcare, displacement, migration, sexual exploitation
- ➤ Tribal policies...a failure ?







FOUCAULDIAN CONCEPT OF POWER AND KNOWLEDGE

- ➤ Origin of the concept: the concept of power structure by Michel Foucault originates from his idea that power is everywhere, not just held by institutions, but present in everyday relationships and knowledge systems.
- ➤ **Tribal Exploitation vs Power structure:** By using Michel Foucault 's theory of power, tribal exploitation can be understood as a result of systemic control through institutions, knowledge and discourse rather than just physical force.
- **➤** Louis Althusser's Interpellation:
 - Ideological State Apparatus
 - Repressive State Apparatus

INTERVIEW: UNFOLDING THE HEART OF THE TRIBALS

- ➤ **Purpose:** Six interviews were conducted on these different tribal people of different communities to know how far they resemble with the fictional characters present in the text.
- ➤ **Reality Vs Fiction:** The kind of persona we came across in the book is very similar to the characters that I came across when they met them on personal level.
- ➤ **Tribal Desire for the socio:** -economic empowerment They need a balance life which consist of both modern and traditional attitude and lifestyle. They want to accepted and respected the way they are.
